## One Parking Monthly Agreement

This Contract for Services (“Agreement”) is made by and between iPark LLC of \_\_\_\_\_ (“iPark”) and Customer (“You”), (“Agreement”).

**Parking Services-** This agreement licenses You to park and lock one vehicle in a parking stall in a designated area in the surface lot and no Title, Possession, nor Bailment is created between You and iPark. You agree to park during the hours that the surface lot is open for business upon payment of the monthly parking rate and a late charge if applicable.

**Self Parking Services-** For Self Parking Services, a temporary license to park one vehicle is hereby granted personally to You and no Title, Possession, nor Bailment is created between You and iPark. We do not provide guards, or assume liability for criminal acts.

**Monthly Parking Rate-** The Monthly rate for rental of parking space is payable one (1) month in advance and must be paid NOT later than the 1<sup>st</sup> day of each month. Payments are accepted at any time throughout the prior month. After the 5<sup>th</sup> of the month You are parking, unpaid tags will automatically be deactivated, this agreement will automatically be canceled, and daily parking rates will apply. NO deductions or allowances from the monthly rates will be made for the days customer does not use the parking facility. All monthly parking contracts are on a month-to-month basis, unless stated otherwise in your lease agreement. **NO REFUNDS WILL BE MADE FOR UNUSED PORTIONS OF A MONTH.**

**Prorated Monthly Rate-** Tags purchased after the 15<sup>th</sup> of the month will be prorated for one half of the month. Proration is only available to new tenant parkers. For accounting purposes, the monthly rental period runs from the 1<sup>st</sup> of one month to the 1<sup>st</sup> of the next month.

**Limitation of Liabilities-** iPark disclaims any liability, to the maximum extent permitted by law, any damage to your person, vehicle or contents therein, including but not limited to, fire, theft, damage, collision, or water damage. **Please do not leave keycard or other valuables in plain view.**

**Hang Tag Issuance-** The monthly hang tag supplied entitles the assigned Tagholder to occupy one (1) parking stall. Your Tag must visible via the front windshield at all times while parked on the lot.

**Applicable Fees-** All fees are non-refundable

- Fee for replacement of lost or damaged tag will be \$25.00, where applicable.
- There will be a \$25.00 late fee charge if we do not receive a payment by the 5<sup>th</sup> day of the month, where applicable.

**Termination for assistance in unlawful entry-** Under no circumstances should You assist any other parkers or visitors to gain entrance or exit with their hang tag. iPark reserves the right to revoke monthly parking privileges upon reasonable suspicion of such activity and Your tag will be voided immediately. Furthermore, You will be required to pay the other person’s parking fees if this practice is observed. iPark reserves the right to repossess all invalid hang tags.

**Termination at will-** This contract is on a month-to-month basis and can be terminated at any time, upon the close of any given month.

**New Vehicles-** Please contact the parking office immediately when changing vehicles, i.e. new car, or deleting a keycard.



All damage must be reported in writing to the parking office before leaving the facility.

**Refund Policy-** This organization has a NO Refund or Return Policy and the sale shall be considered final when made.

**Privacy Policy-** iPark privacy policy has been compiled to better serve those who are concerned with how their “Personally Identifiable Information” (PII) is being used online. PII, as used in US privacy law and information security, is information that can be used on its own or with other information to identify, contact, or locate a single person, or to identify an individual in context.

- When ordering or registering on our site, as appropriate, You may be asked to enter your Name, Email address, Mailing address, Phone number, Credit card information or other details to help you with your experience.
- Information acquired from You when you register with iPark, purchase services from iPark, respond to a survey, or contact our website, are used solely for the purposes of processing Your transactions and making contact with You at a later date.
- Your Personal information is contained behind secured networks and is only accessible by a limited number of persons who have special access rights to such systems, and are required to keep the information confidential. All sensitive/credit information you supply is encrypted via SSL technology.
- Website cookies are used in order to successfully complete transactions and for tracking purposes. Disabling cookies will disable some features that make your site experience more efficient and some of iPark services will not function properly.
- iPark does not sell any information to third parties.
- iParking will only share information with third parties for the purposes of fulfillment of this Agreement. Because of the public nature of surface lots, iPark will only share data with third parties outside of the fulfillment of this Agreement upon request by law enforcement, subpoena, or properly licensed administrative body.
- iPark does not use Google AdSense, but reserves the right to do so in the future.

**Total Integration-** This is the total sum of agreements between You and iPark and no modifications shall occur to this Agreement. iPark expressly denies the authority of any personnel working in any garage to modify this Agreement or sign any contractual agreement which shall bind iPark.

**Severability-** Should any provisions of this Agreement deemed by a court of law to be illegal, invalid or unenforceable, the legality, validity and enforceability of the remaining provisions of this Agreement shall not be affected or impaired thereby.

**Governing Law-** This Agreement shall be governed in all aspects by the laws of the United States of America and by the laws of the State of Indiana.

**Waivers-** The waiver by either party, or a breach of any provision of this Agreement by either party, shall not operate or be construed as a waiver of any other or subsequent breach by either party.

**Agreement-** By accepting (with or without your signature) a parking hang tag for parking, you have accepted the parking rules and regulations mentioned above.
